YOUR BEST Coaching Company ("YBCC") provides a unique blend of triathlon, running and general fitness coaching with a racing team ("**YBCC Racing**") component and a membership option. Athletes can join YBCC and take advantage of any or all of the three components:

1. Coaching - Receive customized and personalized coaching services at fantastic value
2. YBCC Racing Team - Travel with the racing team to the many national and international destinations
3. Member - Take advantage of the fantastic membership discounts, savings and many additional benefits

To join YBCC you must agree to the terms of this membership agreement and waiver of liability (this "YBCC Agreement"), sign and date this Agreement on Page 2, and pay the annual membership fee of \$120. Membership and Termination: YBCC reserves the right to deny membership to any person and to revoke the membership of any person with or without cause. If YBCC revokes your membership or if you chose to voluntarily terminate your membership, your only recourse is a prorated refund of your membership dues.

YBCC Racing Team: We would love for you to enroll and race for the YBCC Racing team, help the team score points and be competitive, which in turn brings value back to you. However, racing for YBCC is in no way mandatory and completely up to you.

Support and Represent our Sponsors: YBCC works hard to attract new sponsors and bring discounts, savings and value back to its members. A big portion of the sponsorship dollars is used to reduce YBCC gear to below cost. Please do your best to promote and represent sponsors and supporters whenever possible. Wearing the YBCC kit, which proudly displays all of our sponsors, is another way to show your appreciation to our sponsors. However, we do understand you support many groups, causes, charities and/or business and nothing is contingent on what gear you wear.

Social Media: You agree that YBCC may use your name and photographs of you in promotional materials including social media (Facebook, Instagram, Twitter), websites, media submissions and newsletters. You agree that YBCC may request that you remove YBCC related social media postings YBCC deems derogatory.

Risks of Participation: You acknowledge that: (i) endurance events, but not limited to running races, triathlons, duathlons, cycling races, adventure races, team relay races, training clinics and all other training for such events (collectively, "Endurance Events") are extreme tests of a person's physical and mental limits; (ii) Endurance Events carry with them potential for property loss, serious injury and death; (the "Risks") and (iii) Endurance Events are conducted in venues open to the public during such events.

Assumption of Risk: You HEREBY ASSUME THE RISKS OF PARTICIPATING IN YBCC EVENTS OF ALL KINDS INCLUDING ENDURANCE EVENTS. You assume all of the Risks including, but no limited to, falls, contact with other participants, effects of weather, defective equipment, the condition of the roads, trails and courses, water hazards, traffic collisions, contact with other runners, cyclists, swimmers or boats and any hazard that may be posed by spectators or volunteers. You agree that prior to participating in a YBCC event, you are responsible for inspecting the course, facilities and equipment to be used to your satisfaction. You further agree that if, at any time, you believe conditions to be unsafe, you will immediately discontinue participation.

Your Condition: You certify that you are physically fit and have sufficiently trained for participation in Endurance Events and have not been advised against participation by a qualified health professional.

Release of Liability: "The Releasees" include: YBCC, YBCC Racing, YBCC event leaders, other YBCC members, volunteers and participants. On behalf of yourself, your executors, heirs, legatees, successors and assigns, YOU HEREBY AGREE TO WAIVE, RELEASE AND DISCHARGE THE RELEASEES FOR, FROM, AND AGAINST ANY AND ALL CLAIMS, LOSSES, OR LIABILITIES OF ANY KIND ARISING FROM PERSONAL INJURY, DISABILITY, DEATH, PROPERTY DAMAGE, THEFT, DAMAGAE, OR ECONOMIC LOSSES, WHICH ARE RELATED TO YOUR PARTICIPATION IN OR TRAVEL TO AND FROM A YBCC EVENT, EVEN IF SUCH CLAIMS, LOSSES, OR LIABILITIES ARE CAUSED BY THE NEGLEGENT ACTS OR OMISSIONS OF THE RELEASEES OR ARE CAUSED BY THE NEGLEGENT ACTS OR OMISSIONS OF ANY OTHER PERSON OR ENTITY.

Agreement Not to Sue: You agree not to sue The Releasees for any of the claims that you have waived, released, or discharged in this Agreement.

Reliance on This Agreement: You acknowledge that your statements on this Agreement are being accepted and relied upon by USA Triathlon, USA Cycling, YBCC, YBCC Racing and The Releasees.

Duty to Follow Safety Guidelines: You agree to follow safety practices, including but not limited to courtesy at all YBCC events. You agree to wear a helmet at all times while riding your bicycle and to use lights on bicycles when required by law or safe practices. Failure to comply is grounds for termination of your YBCC membership.

Minors: The parent or legal guardian who signs this Agreement on behalf of a minor, incapacitated and/or mentally challenged person (the "Represented Person") hereby acknowledges that he or she has the legal capacity and authority to act on behalf of the Represented Person to legally bind the Represented Person to this Agreement. The parent or legal guardian who signs this Agreement agrees to indemnify and hold harmless The Releasees for any expenses incurred, claims made, or liabilities assessed against them, as a result of any insufficiency or legal capacity or authority to act on behalf of the Represented Person in the execution of this Agreement.

Severability: If any provision of this Agreement is unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.
